

# ILLINOIS VOTER REGISTRATION APPLICATION

## TO VOTE YOU MUST:

- Be a United States citizen.
- Be at least 18 years old on or before the next election.
- Live in your election precinct at least 30 days before the next election.
- Not be convicted and in jail.
- Not claim the right to vote anywhere else.

## YOU CAN USE THIS FORM TO:

- Apply to register to vote in the State of Illinois.
- Change your address on your voter registration record.
- Change your name on your voter registration record.

## DEADLINE INFORMATION:

- Mail or deliver this form no later than 28 days before the next election.
- If you do not receive a notice within 4 weeks of mailing or delivering this application, call the Cook County Clerk's office at (312) 603-0906.

## IMPORTANT INFORMATION:

- Federal law requires first-time voters who register by mail to show proof of identification in order to vote. You may be able to satisfy this requirement by providing your driver's license number or, if you don't have a driver's license, the last 4 digits of your social security number on this form. If we are able to verify your identity with one of these numbers, it will not be necessary for you to show ID in order to vote. **If we cannot verify your identity through a valid driver's license or social security number, you will need to provide identification before you can vote.** Acceptable forms of identification include: a copy of a current and valid photo ID, or a copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows your name and address. **A copy** of your identification can be mailed in an envelope to us along with this registration form, or can be shown the first time you vote.
- If you register at a public service agency, any information regarding the agency which assisted you will remain confidential as will any decision not to register.
- If you change your name, you must re-register.
